The directors provide planning and guidance for the Ad Fed, institute and maintain its policies, assist in securing the financial resources required to sustain the organization, foster educational programs, and work to effectively market the organization and increase membership.

Responsibilities

- Participate in establishing the policies and goals that guide the future of AAF-Black Hills.
- Approve new membership applications, appointments, meeting minutes, monthly financial reports, annual budget and any expenditures over \$200.
- Address grievances and discipline members in cases of prejudicial or disruptive conduct.
- Approve a nominating committee and election slate and Fill vacancies on the BOD by appropriate vote
- Review Bylaws amendments and make all decisions related to Club policies, image, goals and finances
- Actively participate in any fundraising campaigns to secure support for the Ad Fed
- Actively work toward the success of the membership recruitment and retention program
- Actively contribute to the success of Ad Fed programs and projects by providing input, encouraging attendance, assisting in sponsorship efforts, and attending programs and events.
- Attendance at 75% of the monthly meetings of the Board of Directors. By majority vote, the Board of Directors is empowered to remove a director who has missed three (3) Board meetings without a legitimate reason or who has demonstrated non-performance of duties as outlined in the Federation By-Laws. In the event of death, resignation, or removal of any director, the Board of Directors shall elect a successor who shall take office immediately and serve until the next annual election. If unable to attend a Board meeting, provide a written notice to the Executive Director or President.
- Chair a committee or serve on at least two committees

Time Required & Qualifications

- Serve on the Board of Directors for a term of (2) years. Terms start in June and commences in May
- Attend monthly Board of Directors meetings (1 hour) and strategic meetings as necessary
- Attend other committee meetings and fulfill committee duties as required
- Attend Ad Fed events and programs on a regular basis.
